**NOW, THEREFORE, BE IT RESOLVED** that the Charter Township of Mt. Morris amends its Schedule I Miscellaneous fee schedule as follows:


SCHEDULE I

MISCELLANEOUS FEES

- A. Home Occupation.....\$200.00 for first time, \$50.00 yearly renewal
- B. Contractors Registration Fee.....\$25.00 yearly
- C. Administrative Cost for work Orders (weed cutting, debris removal, etc.) .....\$50.00
- D. Demolition Permit (residential) (two inspections required) .....\$150.00
- E. Demolition Permit (commercial) (two inspections required) .....based on job cost
- F. Dumpster Permit (good for 30 days) .....\$50.00
  - Or Six Months (when new construction) .....\$100.00
  - Renewal.....\$ is ½ of original cost
- G. Removal of Stop Work Orders or Do Not Occupy.....\$150.00
- H. General Re-Inspections.....\$60.00 per inspection
- I. Special Inspection fee.....\$75.00
- J. Residential Landlord License fee.....\$300.00 for two-year cycle
- K. Conditional Residential Landlord License Fee.....\$ \_\_\_\_\_
- L. Residential Rental Property Re-Inspection fee.....\$75.00 per inspection
- M. Land Divisions.....
  - Subdivision - Split/Combination.....\$50.00 for each new parcel created
  - Metes & Bounds - Split/Combination Residential.....\$75.00 for each new parcel created
  - Metes & Bounds - Split/Combination Commercial.....\$100.00 for each new parcel created
- N. Temporary Signs.....\$50.00 for 30 days (maximum of two permits per year)
- O. Real Estate Request Form.....\$10.00
- P. Police Reports..... \$10.00

Q. Accident Reports.....	\$10.00
R. Finger Prints.....	\$30.00
S. Vehicle Release/Impound Fee.....	\$200.00
T. Breathalyzer Test.....	\$15.00
U. Local Records Check.....	\$10.00
V. Notarize Document.....	\$10.00
W. Copies.....	\$ .50 each copy/side
(no charge for senior citizens)	
Copies of Duplicate Tax Bills.....	\$ .50 per copy/for 3 or more
(includes senior citizens)	
X. Park Rental (Mt. Morris Township residents only) .....	\$200.00 (\$50.00 returned, subject to user condition
Y. Water and Sewer Shut Off Notification.....	\$5.00 per notification
Z. Non-Sufficient Funds Check.....	\$35.00
